HSCIC Update

- 3 VK gave an HSCIC update including as follows:
 - Version 12 of the IGT went live on 13th June, although it is still being taken through the Standards Board for formal approval. The meeting for this is on 19th June (this afternoon) but there is a mandate from the DH anyway.
 - HSCIC leading on an NHS focused cyber security survey over the next couple of weeks
 - Work will be starting very early on version 13 of the IGT, the main reason for this being more work with Local Government. HSCIC will also be liaising and working more with smaller organisations this year e.g. GP & dental practices, eye care providers, voluntary sector – similar to that with research and education.
 - The revised guidance for IGT submissions to support section 251 applications should be available in time for the Training Day on 2nd July.
 - The strategic information governance network is being reinitiated to encourage wider consultation (had existed previously through the Strategic Health Authorities until they were abolished in April 2013).
- 4 BK thanked VK for working with us and the openness to discussion and the reaction to comments and suggestions have been really appreciated. BK wondered whether there would be value in the Working Group having amore more formal relationship with the HSCIC, and if so in what direction might this be? It was agreed to consider this further under the terms of reference agenda item.
- VK gave an update on the proposed incident reporting tool that had been raised by the group. A meeting had taken place with an advisory group including NHS and LA representatives two days earlier. The consensus was not to make the approach too structured. There had been some support for the SIRO needing to log-in to the IGT and sign-off the incident report but others felt that they would not do that. The proposal is to audit the sign-off and record this in the IGT e.g. send draft report to SIRO/DPO and once emailed back as approved then record on the

system as "approved" (possibly a mandatory field). A facility to add contacts and who should be consulted is also being considered. The aim is to include the agreed facility in the October release. The working group agreed that this approach was a pragmatic solution and then could be reviewed later once there was some experience with it.

VK asked whether there was a volunteer to join the IGT system design group. For instance the design group will be looking at reporting cyber security incidents in the next year. TP volunteered and LS said he would be a back-up if TP not available.

Terms of Reference

A number of revisions were discussed. **Action 6.6**: A revised version will be circulated for discussion at the next meeting.

Training Day on 2nd July

Following the initial draft programme from SL, a number of further revisions had been agreed via email. The group reviewed the programme and made some further suggestions which will be incorporated in the final version.

Proposals for the Knowledge Base

9 SL reported that this will be the focus after the Training Day as suggestions are needed by the end of August. **Action 6.7**: request for members to offer up some of the things they have for potential inclusion in the Knowledge Base.

Potential for using some of the content from the Training Day etc to put together a document/paper to raise awareness in HE about the issues

This was a suggestion from AB. BK thought it a good idea to create more of a marketing document and to consider this further at the next meeting.

Google cloud-based NIHR collaboration portal

- II KH raised this issue. It is now a requirement to use the NIHR's collaboration portal for research funded through the NIHR. Initial concerns include:
 - Separate process of email accounts
 - Apparent lack of IG around its use

Collaboration might involve data. The portal is based on Google Drive and there has been a health data breach involving Google Drive.

KBH said that the portal obviously impacts on her too with her role at the NIHR CRN Coordinating Centre and she will be looking in to it further. KH is going to take a view on its use on behalf of KCL where there is a standard process for reviewing systems. A key question is whether the portal conflicts or otherwise interacts with the IGT requirement. It was agreed to discuss this further at the next meeting. **Action 6.8**: KH and KBH to liaise on the portal assessment. **Action 6.9**: VK will check whether there is any HSCIC advice on this.

Any other business

- 13 TP noted that there had been mention by HSCIC and in a Guardian newspaper report that spot-checks might be introduced? VK said there aren't any specifics at the moment but HSCIC are considering external assessment in further alignment with ISO 27001.
- MT said that a Janet colleague Henry Hughes was the project director for a potential project with the Farr Institute, Medical Bioinformatics initiative and the Administrative Data Research Centres on a higher assurance network between the centres and for an Authentication, Authorisation and Accounting Infrastructure (AAAI). The information governance aspects were very important in this and it would help if Henry could have access to the group e.g. via BK. BK said she would be very happy to be in touch on this. **Action 6.10**: MT to ask HH to be in touch with BK.

Date of next meeting

It was proposed that there should be a meeting to review the Training Day in mid-June (post-meeting note, this was later abandoned) and a meeting on 13th August 2014 so that the Knowledge Base proposals could be discussed.
