What is SWAN?



- Scottish Wide Area Network
- Scotland PSN but with two tier security approach
- Enables secure sharing of information between Public Sector Organisations
- Is a Contract that is available to all Public Sector entities in Scotland
- Delivered by Capita

Progress

- National Susservices
- 43 Organisations have now joined SWENT and
- Over 3000 sites live
- Roll-out slower than expected
- Service issues between October 14 and June 15.
 - Independent Audit
 - Service Improvement plan (SIP)
 - Major incidents significantly reduce
- Value added services (VAS)
 - Development delayed due to Service and rollout issues
 - However Managed LAN now available and more to follow in the next year



 - Includes the SWAN Information Assurance Panel
 - Includes representation from existing and any eligible future Call-Off Customers.
- SWAN User and Delivery Forum
 - Considers all matters regarding the delivery and functioning of the Services
 - Only Service Recipients able to attend




- Broadband connectivity

 - Internet


SWAN Shared Services

National Services Scotland

- Shared services
 - Service desk
 - Network management
- Technical services
 - DNS (hosting and resolution)
 - NTP
 - Mail Relay (including AV, anti-spam)
 - Web filtering (IWF and URL)
 - Secure Gateways (internal and external)
 - Remote Access (per-user cost)
 - Network monitoring (Solarwinds Orion)
 - CPE management and support

Value Added Services



- 1. Managed LAN Service
- 2. Small Site Secure WiFi
- 3. Voice Services
 - SIP Trunks
 - Non Geographic Numbering Services
 - Managed IP Voice Services (including IP PBX and Hosted)
- 4. Building and Campus WiFi
- 5. Professional Services to include for example
 - Specialist consultancy and technical skills
 - Specific disciplines e.g. Project and Program Management
- 6. Virtual Information Security Manager
- 7. SWAN Roam
- 8. Billing as a Service
 - SWAN circuits and related charges on behalf of Call–Off Customers
 - Onward Voice Billing for Call-Off Customers to end customers
- 9. Video Conferencing
- 10. Lone Worker

Areas for Collaboration?



- SWAN Roam
 - At concept stage
 - Does not have to be delivered by Capita
 - HE Representation on SWAN Design Authority
- Video Conferencing
 - Guest Access to allow non SWAN organisations to communicate
 - Not operated by Capita

NHS Non SWAN Activities



- NHSmail2
 - To replace NHSmail services for over 100,000 NHSScotland staff
 - Procurement complete
 - Microsoft platform in a private cloud.
 - More optional services such as
 - Skype for Business
 - Accenture awarded contract
 - Transition starts March 2016.
- NHSScotland looking at Office 365

NHS Non SWAN Activities



- PACS
 - Upgrade (V11) programme complete
 - Enhanced functionality including compression of images to save cost.
 - Secure sharing with HE Farr
