SWAN (N3 Replacement)

What is SWAN?



- Scottish Wide Area Network
- Scotland PSN but with two tier security approach
- This would replace N3
- NHS would lead a Vanguard of up to 3 other organisations/ consortiums
- Would remain a NHS contract, with NSS being the contract and design Authority.

Why SWAN?



- Supports
 - the McClelland review of Scottish Public Sector ICT.
 - Scotland digital future action plan. Focus on broadband delivery.
 - Integration of Health and Social Care
- To make savings by aggregating public sector demand for Broadband services.

Progress



- High level requirements complete.
 - Business Continuity is top priority
 - Cost of migration is top concern
 - One contract is preferred.
- Statement of requirement in progress
 - Output based specification nearly complete
 - Tier 1 and tier 2 standards being defined
 - Extensive Consultation with Vanguard partners
- Project Team and Governance.
 - NHS lead SWAN Vanguard
 - Legal advisors D&W on board
 - Project manager, procurement, Financial and technical advisors in place

 - Network management







Next steps




- OBS completed by mid November

NHS VC National Service




- Makes use of existing NHSBoard equipment and support.
- National Directory and Local conference booking
 - Populated from NHSBoard systems
 - Available on line
 - Hosted in Data Centre.
- National Video Routing Service
 - Routes Board A to Board B Video over N3.
- North of Scotland pilot extended to all Boards who want to join.

VC Progress



- National Gatekeeper and Management System live.
 - 692 Endpoints registered at September 12 about 100 to do
- Dial plan being rolled out to rest of Scotland.
 - Enough national gatekeeper licences
 - A further 100 TMS licences have been procured
- remote access infrastructure live in July
- On-line directory live September 2011
 - Developed by NHSHighland
- VC Project Board endorse move to shared MCU infrastructure approach
