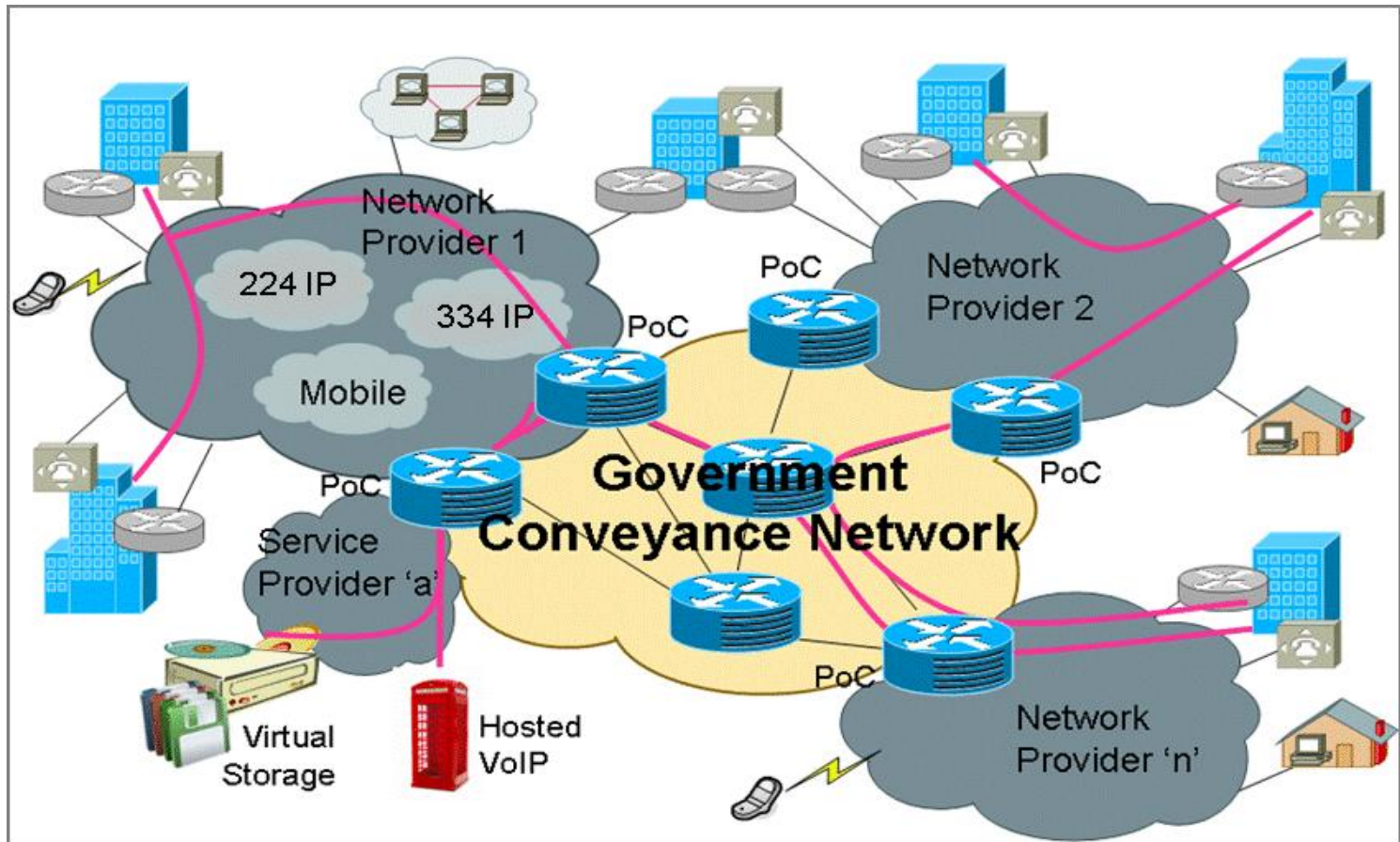

PSN Proposition

- Create the effect of a single network
 - Enabler for service efficiencies
 - Must be fit for purpose – security, standards, performance
 - Creates a market place
- To achieve this in the most cost effective way
 - Reduced procurement costs
 - Reduced implementation costs
 - Reduced service costs

PSN – A Network of Networks

- A private internet for the Public Sector
- Security assured
- Service assured
- Open technical standards



- Co-ordinated commercial standards
- Shareable services

PSN is becoming a reality

- 'Early Delivery' projects underway – there are currently three phases mapped out
 1. Hampshire & Kent deliveries will create initial 'GCN' and DNSP – testing happening now – VoIP telephone call successfully made.
 2. Virgin and Global Crossing have achieved Interim PSN accreditation
 3. Connection to the Government Secure intranet (GSI), to allow parallel running during transition, in Q2 2011.
 4. Other Customers and supplier connections introduced from Q2 2011.
- Four GCN suppliers have signed DOU
- MoJ, DWP, HMRC, MoD all looking to begin transition during 2011/12
- PSNA operational, Q2 2011 (PSN moving from development to deployment)
- PSN On Boarding workshops have been run - more being arranged
